Invitation for Bids for the Construction of Office Quarter Building at Putalibazar Municipality, Syangja



The Putalibazar Municipality has allocated funds towards the cost of **Construction of Office Quarter Building at Putalibazar Municipality, Syangja** and intends to apply part of the funds to cover eligible payments under the Contract for PM/W/NCB/BC/02/2074/75. Bidding is open to all eligible Nepalese Bidders.
2. Putalibazar Municipality, Office of Municipal Executive invites sealed bids or electronic bids from eligible bidders for the **Construction of Office Quarter Building at Putalibazar Municipality, Syangja** under National Competitive Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
Minimum Work experience of similar size and nature: Successfully completion of One RCC frame structured building (one storey) having minimum project cost of Rs. 4.4 million within last ten years.

A complete set of Bidding Documents may be purchased from the Office of Municipal Executive Putalibazar-1, Syangja by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **Rs. 3000.00** till 22 Dec, 2017.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 6. Sealed or electronic bids must be submitted to the office Putalibazar Municipality, Office of Municipal Executive, Putalibazar-1, Syangja by hand/courier or through PPMO website www.bolpatra.gov.np on or before 12:00 hrs noon on 24 Dec, 2017. Bids received after this deadline will be rejected.

Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **Rs. 135,000.00**, which shall be valid for 30 days beyond the validity period of the bid (i.e. 120 days from the deadline of bid submission).
